

FREEPOINT COMMODITIES LLC APPROVED RIN GENERATORS

Update: August 14, 2019

In accordance with a Spot Purchase Agreement and the General Terms & Conditions attached thereto, including specifically the Addendum for the Sale of Renewable Identification Numbers (“RINs”), and unless otherwise agreed to in writing, RINs to be purchased by FREEPOINT COMMODITIES LLC must originate from sources listed below.

- 1. QAP RINs.** All RINs verified under EPA’s Quality Assurance Program (“QAP”), as evidenced by being QAP “Type 10” in EMTS, are approved for purchase; **provided however that FREEPOINT COMMODITIES LLC reserves the right to reject QAP verified RINs for good cause.**
- 2. Domestic RIN Generators.** For transfers of RINs that have been separated pursuant to the RFS regulation (“K2” RINs), without a concurrent sale of renewable fuel, RINs generated by domestic producers from the following list are approved.
